INFORMATION FOR PROSPECTIVE MEMBERS AND THIER SPOUSES

1. The election of Members is vested solely in the Management Committee of the Club.
2. Candidates must be proposed and seconded by two Members and must deposit the amount of the current Administration Fee with the application which is refunded should your application is not approved. Should the Applicant not take up membership the amount of the Administration Fee will be forfeited.
3. The Application Form must be completed by the Applicant and signed in the presence of the Proposer who must also sign the form. Candidates must state their current occupation; in the case of a retired applicant this will be their former occupation. Company Directors must state the nature of their business activity.
4. The Proposer and the Seconder must be fully paid up Members of the Club for at least twelve months. From their personal knowledge of the Applicant they must be able to vouch for their respectability and fitness to be a Member of the Club. By signing this Application the Proposer and Seconder accept responsibility for the behaviour of the Applicant in the Club for the first twelve months of their membership.
5. The name, address and occupation of each candidate and the names of their Proposer and Seconder will be posted on the Club notice board for seven days before the meeting of the committee at which their membership application will be considered.
6. Should the applicant not know a member to propose and second their application they will be asked to meet two committee members to appreciate the rules of The Club and understand its ethics.
7. Until the decision of the committee has been made known and any annual subscription paid, the Applicant may only use the facilities of the Club as a guest of a member. The Rules governing the introduction of guests into the Club will apply
